2010 Action Plan Update (In order of strategy and activity).

Strategy 2A — Include a brief update during each FIPAC and Goal Team meeting.

- Topics for the Fall 2010 FIPAC meeting will be Suicide and Human Trafficking.
 - Dr. Ceslo, who is working on a suicide prevention grant, has been recommended as a speaker. A suicide prevention hotline representative may also be contacted to speak.
 - Jan Davis, Keely Smith and possibly a law enforcement officer will present on human trafficking.

Activity 2B(4) — Urban Pilot Community and States Resources Meeting.

- Cindy Magnole provided a brief update on the Urban Pilot of the Community and State Resources meeting that was held in Miami on June 3, 2010.
- Responses to the meeting were extremely positive. Copies of evaluation responses were provided to Goal Team members.
- Updates were provided on Click-It or Ticket, drowning, poisoning and Mothers Against Drunk Driving (MADD).

Activity 2B(5) — Rural Pilot Community and States Resources Meeting.

- It was decided to try to hold the Rural Pilot in conjunction with the Spring 2011 FIPAC meeting, which will most likely be held in May.
- Discussion centered on whether the Rural Pilot should include all of the rural counties that the Tampa Poison Control Center serves, or if a few counties with similar injury trends should be selected.
 - Lani will work with Kyla to provide some data on the counties served. This will be provided to Goal Team 2 members to help determine the best course for the Rural Pilot.
- Additional topics of discussion included:
 - Bonnie McDougle could offer continuing education units (CEUs) for attendees.
 - Telemedicine could possibly be used for the more remote counties.
